The University of Pennsylvania Department of Family Medicine and Community Health in collaboration with the Guatemala-Penn-Partners and the Hospitalito Atitlan is offering the **Global Health Fellowship in Comprehensive Health**.

This unique opportunity allows a fellow to develop clinical, educational, and leadership skills in the care of underserved populations in West Philadelphia and Santiago Atitlan, Guatemala.

The fellow has the option of a 1 or 2 –yr. fellowship with clinical, community outreach, and teaching responsibilities at both Penn Family Care and the Hospitalito Atitlan. Responsibilities will include low risk OB, inpatient, outpatient, and community outreach, as well as, supervision of residents and medical students teaching in the Hospitalito.

## Overview of Program

**MPH Track:** This is a two-year track for the participant who is interested in completing an MPH. The fellow will provide clinical care and teaching alternating semesters between Philadelphia and the Hospitalito Atitlan while continuously taking MPH courses with a global health concentration through the Penn MPH program.

## Certification in Tropical

**Medicine Track:** This is a 1 year track for the participant who is interested in completing coursework for the CTropMed exam. This fellow will spend approx. 5.5 months in both Philadelphia and Atitlan and 2-4 weeks at the University of Minnesota Global Health Course.

## Global Health Leadership

**Track:** This is a 1-year track for the participant who would like the flexibility to identify areas of clinical, research, or leadership interest for

enhanced training such as ultrasound, working with the mixed methods lab on a community based research project, or using the tuition benefit to take leadership courses at Penn. This track does not lead to any additional credential or degree. Weaving in the principles of humility, self-sacrifice, collaboration, and equity, the fellowship seeks to enable the participant to develop **competencies** in:

- 1) Clinical care in resource limited environments
- 2) Community-based health care and participatory research
- 3) Faculty development including curriculum development
- 4) Leadership including partnership development

The **fellow best-suited** to this opportunity is:

- fluent in Spanish and adaptable
- board-certified or board eligible in family medicine, and
- willing to support partnership development in Guatemala.
